The notice shall specify the time, date, place, and agenda of the meeting; be it further

RESOLVED, the time for regular meetings will begin at 6 o'clock p.m., unless otherwise provided by the Chairperson; and be it further

RESOLVED, this Resolution repeals Resolution CSC-003-84.


