**RELATIVE TO THE AMENDMENT OF DEPARTMENT OF
ADMINISTRATION'S DRUG-FREE WORKPLACE PROGRAM, SECTION 24:
"ACCIDENT AND UNSAFE PRACTICE TESTING"**

WHEREAS, the Department of Administration's Drug-Free Workplace Program (DFWP) Operating Policy and Procedures was adopted in 1995; and

WHEREAS, in consultation with the Department of Administration to amend and add a paragraph under *Section 24, Accident and Unsafe Practice Testing*; and

WHEREAS, the Civil Service Commission believes that the addition of the paragraph is necessary for the safety and efficiency of the government of Guam; and

WHEREAS, the Civil Service Commission believes that the existing policy reflected in Section 24 of the Department of Administration's DFWP is somewhat unclear in meaning as relative to an accident in which no one is injured and the damage is slight; and

NOW, THEREFORE, BE IT RESOLVED that a paragraph, *"The accident or unsafe practices occurs when a passenger is in which the vehicle"* added as 24.a(3) under the Department of Administration's Drug-Free Workplace Policy and Procedures is approved and, a copy be transmitted to the Governor and Lieutenant Governor for promulgation.
