**RELATIVE TO COMMENDING MR. MANUEL R. PINAUIB UPON HIS YEARS OF SERVICE,
DEDICATION AND COMMITMENT TO THE GUAM CIVIL SERVICE COMMISSION
CSC RESOLUTION NO. 2015-04**

WHEREAS, MANUEL R. PINAUIB, is commonly known to his family, friends and colleagues, as "Manny"; and

WHEREAS, Manny proudly served as a Construction Management Engineer for the Naval Facilities Engineering Command for 40 years from February 11, 1968, to January 3, 2008, where he received numerous commendations and awards for his professionalism on the job; and

WHEREAS, on February 1, 1990, while still employed at NavFac, Manny was first appointed by Governor Joseph F. Ada to serve on the Civil Service Commission and on May 20, 1994, was reappointed by Acting Governor Frank F. Blas to serve a six (6) year term; and

WHEREAS, recognizing his dedication and willingness to serve he was once again reappointed on April 28, 2000, by Acting Governor Madeleine Z. Bordallo and again by Governor Carl T.C. Gutierrez on February 12, 2001, to serve a six (6) year term; and

WHEREAS, on April 6, 2009, Manny was again reappointed by Governor Felix P. Camacho to serve another six (6) year term; and

WHEREAS, upon taking office in January 2011, Governor Eddie Baza Calvo retained Manny to continue serving on the Commission; and

WHEREAS, Manny has been appointed and reappointed to serve under four (4) Governors, the most of any Commissioner in the history of the Civil Service Commission; and

WHEREAS, during Manny's years of service he dedicated his time and efforts to ensure that all matters before the Commission were heard fairly and impartially with his precise and meticulous deliberations that were known for complete thoroughness; and

WHEREAS, after 25 years of service, the longest in the history of the Civil Service Commission, Manny has respectively decided to step down effective at the end of his term on September 30, 2015. Manny will be greatly missed for his dedication and diligence to serve; **NOW THEREFORE**

BE IT RESOLVED, that the Civil Service Commission wishes to convey to Manuel R. Pinauin and his family our sincere gratitude and admiration for his dedicated service and significant contributions to the people of Guam, the employees and the Government of Guam, and the COMMISSION; and

BE IT FURTHER RESOLVED, that this resolution be forwarded to the family of Manuel R. Pinauin and copies be transmitted to the Governor, Lieutenant Governor, and the Guam Legislature.
