CSC RESOLUTION NO. 88-004

RELATIVE TO EXPRESSING THE CONDOLENCES OF THE CIVIL SERVICE COMMISSION TO THE FAMILY OF THE LATE EVELYN T. QUIEL AND POSTHUMOUSLY COMMENDING EVELYN FOR HER EXEMPLARY PERFORMANCE

BE IT RESOLVED BY THE CIVIL SERVICE COMMISSION:

WHEREAS, Evelyn T. Quiel (Evelyn), was a Management Analyst IV and transferred to the Civil Service Commission on August 26, 1987; and

WHEREAS, during her brief tenure with the Commission, Evelyn undertook or participated in significant projects which were of tremendous impact to the merit system; and

WHEREAS, these projects were the development of the Magnificent Seven merit recognition program and the reformulation of the pay range schedule for GovGuam civil service employees to reflect the Option 1 increases;

WHEREAS, the Magnificent Seven Program was a new government-wide program and required insightful and skillful analysis of how the merit system should be applied to recognize proficient employees; Evelyn's professional and analytical skills contributed significantly to the huge success of the Program; and

WHEREAS, the reformulation of the pay range schedule was critical and through her professional diligence and mathematical knowledge, skills, and abilities, she was able to develop a mathematical formula to apply to the computation of the various salary levels; and further, discovered inadvertent but significant errors in the initial formulation of the Option 1 pay range schedule; and

WHEREAS, Evelyn performed these projects exceptionally, with the utmost professionalism, and in an exemplary manner in spite of the fact she was afflicted with a terminal illness;

WHEREAS, Evelyn passed away suddenly on March 5, 1988, and is now in the grace of our Lord; and

WHEREAS, Evelyn was a fine and decent Christian person who will always be remembered; NOW, THEREFORE, BE IT

RESOLVED, that the Civil Service Commission does extend its deepest sympathy to the family of beloved Evelyn, and does share in their grief; and be it further

RESOLVED, that the passing of Evelyn is a loss to the Commission, the Government of Guam and the community; and be it further

RESOLVED, that Evelyn T. Quiel rest in peace in the grace of our Lord; and be it further

RESOLVED, that the Civil Service Commission adopt this resolution by assigning their signatures, and that copies shall be presented to the family of Evelyn T. Quiel and transmitted to the Governor of Guam.
