- WHEREAS, JOHN CRUZ was always willing to lend a helping hand to any of the staff, professionally or personally, who needed assistance; and
- WHEREAS, JOHN CRUZ, over the course of his employment with the Commission was on several occasions temporarily detailed to leadership positions of Acting Deputy Director, Acting Executive Director, Personnel Management Administrator; and
- WHEREAS, JOHN CRUZ has served the Government of Guam a total of 22.5 years, and the Civil Service Commission 13 years; and
- WHEREAS, JOHN CRUZ has opted to retire from government service and pursue other interests, effective July 26, 1991; and
- WHEREAS, JOHN CRUZ will be missed professionally, socially, and personally; now, therefore, be it


