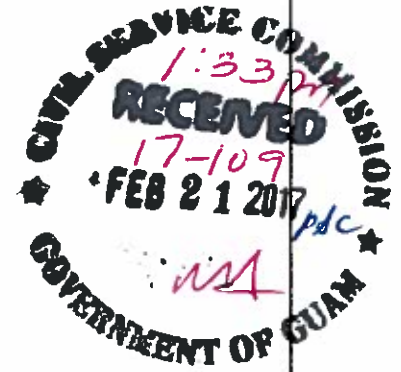




Letter of Resignation


