**STIPULATION TO AMEND  
JUDGMENT OF DISMISSAL**

Management, Port Authority of Guam ("Management"), through its attorneys of record, The Law Offices of Phillips & Bordallo, P.C., by Michael F. Phillips, and Employee, Pearl Angel Cruz ("Employee"), through Jerry M. Rivera, Lay Representative, hereby stipulate and request to amend the Judgment of Dismissal adjudged on August 15, 2017.

On August 4, 2017, Employee withdrew her appeal in the above-entitled action. In exchange for Employee's withdrawal and agreement not to return to employment at the Port Authority of Guam or apply for future employment at the Port Authority of Guam, Management agrees to change Employee's status from termination to resignation.
