

 22 Directors of Management PORT AUTHORITY OF GUAM to jointly stipulate that the terms of  
 23 a private undisclosed Settlement Agreement between the parties shall be entered as the

1 Judgment of the Civil Service Commission in the above captioned action, which Settlement  
2 rescinds the adverse action against Employee and reinstates Employee to employment with  
3 Management PORT AUTHORITY OF GUAM. By this reference, the terms of the undisclosed  
4 Settlement Agreement are incorporated into this Judgment, though the Settlement Agreement
