WHEREAS, Commissioner Tuncap presided over many appeal/complaint hearings and Adverse Actions, Grievances, Equal Employment Opportunities, Lay-offs, Bad Faith, Furloughs, Priority Placements, Post Audits, Notices of Personnel Actions, Public Protection act "aka: Whistle Blower," Ethics in Procurement and Political Activity "aka: Mini-Hatch;" and,

WHEREAS, Commissioner Tuncap will be deeply missed and her absence from the Civil Service Commission will be a great loss; and,

WHEREAS, Commissioner Tuncap took on a challenging role. Not many citizens are not willing to volunteer to work for the CSC Board.
