Calvo, Chairman; John Smith, Vice Chairman; Priscilla T. Tuncap, Commissioner; Emilia F. Rice, Commissioner; Anthony P. Benavente, Commissioner, and Robert C. Taitano, Commissioner.

The Commission heard arguments on Management's Motion and ruled in Management's favor in a vote of 6 to 0.

The Decision and Judgment in this matter entered July 31, 2020, is hereby amended as follows: on Page 3, the CSC hereby modifies staff recommendation number 3 as follows: "Staff recommends that the Commission find that the selection by GIAA for the Airport Police Supervisor position is in compliance with the merit system process, and takes no position or action on staff recommendations 1 and 2."
